- I/We have received and reviewed the tuition information for School Year 2020/2021. We understand that the tuition does not cover fees, books, supplies or uniforms. We accept our responsibility to be the first teachers of our child(ren). We commit them to the care of Knoxville-Area Catholic Schools in the cooperative venture of Catholic education.
- I/We realize that the tuition our family pays does not completely cover the cost of educating our child(ren) in the Knoxville-Area Catholic Schools for the 2020/2021 school year. As a result, we understand and are grateful that our parish pays a Standard Parish Contribution to the schools for our family through a contribution to the Knoxville Region Catholic Schools Operating Fund.
- I/We realize the Standard Parish Contribution is based on the number of children in our family attending Knoxville-Area Catholic Schools (1-child = \$200, 2 children = \$1,000, 3 children = \$3,000, 4 or more children at one school = \$5,500, or 5 or more at two schools = \$6,000)
- I/We accept our call to be stewards of our resources and the resources of our parish and our school community and have considered our family's resources and the needs of our parish and school(s) in the light of our own stewardship.

**I/ We therefore promise and pledge for the 2020/2021 school year (please read carefully and select only one option below):**

- 1. We are willing and able to pay the Gross Catholic Tuition. We understand that we are asking our parish NOT TO PAY the Standard Parish Contribution to the school for our family (see amounts above).

- Single payment of tuition directly to each school. This payment must be received on or before the date designated by the school. A discount *may* be applied for this option. Discount applies to tuition only. Please note that fees and books may be included in amount due. If the single payment is not made by the designated date for the school, tuition must be paid through the school's electronic monthly payment plan.
- Monthly payment plan. Electronic bank draft of tuition each month. Please note that fees and books may be included in the monthly amount due.

**\*Note: Before registration can be completed, a Catholic family must have the Parish Affiliation Certification (bottom of this form) signed by your Pastor or his designee. This form must be completed by the published deadline in your school registration packet. Forms and instructions for requesting Supplemental Tuition Support are available from your parish or school business offices.**
